- PTMD or RDMD recreational amenities are defined as Lakes, Beaches, Fishing, Sports Courts, Pavilions/Gazebos, Orchards, Farm Fields.
- Individuals utilizing PTMD or RDMD recreational amenities are required to carry a current Recreation Pass.
- Recreational Pass holders are allowed two guests per card holder.
- For events or gatherings that outnumber the allowable guests per Recreation Pass holder, an Event Notification Form is required to be submitted to clientservices@advancehoa.com **during normal business hours, at least 36 hours prior to the event.**
- District facilities are closed from 10:00 p.m. – 5:00 a.m. seven days a week.
- Fire pits must be manufactured, portable fire pits.
- Charcoal grills are permitted but must be removed by the end of the event.
- No dumping of ash or charcoal allowed.
- Temporary awnings and umbrellas for shade are permitted as long as such structure is not left unattended and is removed when user leaves.
- Loud music on the beaches, lakes, or parks are not permitted with audible sound beyond 25 feet.
- Respect of the community and your neighbors must be observed.
- Commercial events or events charging an entry fee are not permitted.
- Proper disposal of all trash before leaving is required.
- The private, personal consumption of alcohol is permitted for persons 21 years of age or older and in compliance with all applicable State and Local laws and regulations.
- Vandalism or destruction of property will not be tolerated. Cutting, disfiguring or removal of trees, rocks, or shrubs from the natural environment is not permissible.
- The undersigned is responsible for any damage caused to District facilities during this event.
- Patrol services will be notified and aware of the event details.
